Dear Members;

Welcome to the 2015 season of the Allenhurst Beach Club. We are sure that everyone is looking forward to this summer after a very long, cold and snowy winter. The Beach Club will open for Memorial Day weekend from Friday, May 22<sup>nd</sup> through Monday May 25<sup>th</sup>. Thereafter, the Allenhurst Beach Club will be open for weekends only through June 14<sup>th</sup>. The Allenhurst Beach Club will be open for daily use beginning June 18<sup>th</sup> through September 13<sup>th</sup>. As has been the case for several years, the Allenhurst Beach Club is operating at full membership capacity such that new memberships cannot be offered except to new residents to the Borough.

The 2015 season of the Allenhurst Beach Club should prove to be one of the most exiting beach seasons in the history of the ABC. The Army Corps of Engineers has finally scheduled our phase of beach replenishment and if their schedule proves true, the Allenhurst Beach should be ready for opening day. While the Army Corp plan involves filling in the "lagoon", we are now led to believe the "L" jetty will not be buried. Either way, we do expect that an overcrowded beach will be a thing of the past. Given the uncertainty of the start of replenishment, we decided to defer placement of additional cabanas until next year.

For the first time in forever, even for our longest standing members, we will have a brand new restaurant facility this year. As most of you have seen, the construction of the beach club restaurant has steadily progressed and we are very optimistic that the restaurant will be open soon. While the exact opening date has not yet been set, we do expect to have a new and beautiful restaurant open for this summer season. If you did not know, the roof of the restaurant was designed to provide additional deck space for exclusive use by the members during beach club hours. Mister C's was awarded the bid to operate the restaurant and Karen and Chic are just as excited to be back as we are to have them back.

Also for the first time in forever, the Allenhurst Board of Commissioners has, by way of formal resolution, codified the rules for membership in the Club and for licensing of beach facilities. These new rules were discussed on the record at several meetings and were published in draft form on the Borough web site. The Board invited and received comments from both resident and non-resident members. One of the new rules limits each facility to two families. Each family consists of no more than three generations, (grandparents, parents and children). Additional members may be added to a facility for a surcharge of \$250.00 each. Because it was very challenging to codify the ABC membership rules, we expect that these rules will have to be amended from time to time, particularly in the first few years. Accordingly, if you feel that you or your family has been adversely affected by these rules, you are invited to attend a public meeting and petition to the Board for relief. Any amendments or exceptions we make to the rules will then be a matter of public record.

In addition to formalizing the rules for membership, the Board of Commissioners has authorized increases in membership and facility fees. These increases were necessitated by the costs incurred over the last several years in doing significant restoration projects such as the restaurant and also in doing long overdue maintenance to other areas of the club. These are the first significant increase in fees in many years and even with these increases, it should be noted that the cost of membership in the ABC is still well below those fees charged by other beach clubs in the area.

The Recreation program and Swim Team will be returning under the direction of Warren Towns. In order to cover our expenses, the cost for the recreation program has increased. The program shall be open to all children who are members of the Allenhurst Beach Club between the ages of five (5) years and twelve (12) years at the discretion of the Recreation Director. The program shall run for seven (7) weeks, during the Beach Club season from 10:00 AM to 3:00 PM, Monday through Friday. The cost for participation in this program will be four hundred fifty (\$450.00) dollars for the first child and four hundred (\$400.00)

dollars per child for additional children from the same family. Tina Pritzlaff, our yoga instructor, will be returning to teach oceanfront yoga classes.

The legendary SS Allenhurst shuttle service will be ready for the summer season and the Fire Department will again be raffling off a prime beach parking space at the Allenhurst Beach Club. The winner will be able to pick a spot at either the cabana or main entrance.

Please note that all cabana principals must complete a User Agreement which clarifies the terms and conditions for the use of the cabana. We remind members that due to the lack of beach and storage space, we are asking that you limit chairs and umbrellas to the number of individuals on your membership. If you have five members on your application, you can only store five chairs. Information on the navy blue beach chairs and umbrellas by Lacks Outdoor Furniture is included in this application. We look forward to the 2015 season with great anticipation and we appreciate your cooperation and patience as we continue to rebuild and improve the Allenhurst Beach Club.

## ALLENHURST BEACH CLUB RULES

1. IDENTIFICATION – NO ONE will be permitted entrance into the Beach Club without being identified as a member or guest of a member. Identification points will be set up at each Beach Club entrance for member's convenience.
2. GUESTS – Guests MUST be accompanied by a Club member. Guests are permitted into the Club with Daily Guest passes only – no daily bracelets are permitted. Any member found bringing a guest into the Beach Club without paying the prescribed fee shall be subject to revocation of membership and such guest shall be subject to prohibition of use of the facilities as well.
3. ENTRANCES – Prior to the opening of the Beach Club, members and guests may line up at the Club entrance. Under no circumstances are members or guests permitted to leave personal belongings, such as beach bags towels, etc., as a substitute or in lieu of their presence at any Club entrance, as a means to reserve their place in line for Beach Club entry. All unattended items found placed at the entrances shall be removed and turned over to the Allenhurst Police Department for safekeeping.
4. DAMAGE OR LOSS OF ARTICLES – The Borough of Allenhurst will not be responsible for damage or loss of equipment, clothing, bathing apparel, or valuables left in any part of the establishment, whether or not same has been entrusted to ABC employees or checked with management.
5. GLASSWARE – Absolutely no bottled goods may be used at any location around the pool or deck area.
6. RECYCLING – Members are responsible for using the appropriate receptacles for discarding all refuse and recyclables as required by Borough ordinance.
7. LOUNGES – Lounges are for the use of all members and guests on a first come basis and may not be saved or rearranged from one location to another, or from one deck area to another deck area. Only one lounge shall be permitted per member or guest.
8. PLAYPENS/STROLLERS – Playpens will be allowed by the main gate area and the deck pavilion area. Strollers are not permitted to be walked around the pool area.
9. CHILDREN – ALL children under the age of 5 years old must be listed on this application and must have a copy of a birth certificate attached to the application. Children under 12 must be accompanied by an adult. Parents/guardians are responsible for the conduct of their children at all times. Unruly and unmanageable children will be asked to leave.
10. KEYS – Each bathhouse will receive two keys for the season. Beach Club staff will be available to assist you with entrance to your bathhouse as necessary.
11. TRESPASS – Anyone entering the Beach Club unlawfully will be subject to fines per Ordinance 2009-16.
12. PETS – No dogs, pets or other animals are permitted on the ABC property, which includes the boardwalk.
13. KAYAKS – A kayak rack will be available at the rate of \$50 for the season. Space will be allocated on a first come, first served basis. There will be a specific marked lane for the kayakers to use when entering or exiting the ocean. Kayaks remaining after season's end will become property of the Borough.

14. BATHING – Bathing and surfers are forbidden to bathe/surf outside designated areas, or at such times, when in the professional opinion of management or lifeguards, ocean bathing is dangerous or unsafe. Bathing after hours is prohibited.
15. DANCES – Summer youth dances are sponsored solely by the ABC and will, therefore, be strictly limited to ABC members and residents of Borough of Allenhurst.
16. GROUNDS – Members and guests will cooperate in keeping beach pool areas, grounds and other ABC facilities in clean condition. Deck, stairs and passageways shall not be obstructed by members or guests. Anyone defacing or damaging any ABC property, including, but not limited to lockers, cabanas, etc., shall be subject to immediate expulsion from the Club and prosecution to the full extent of the law. There will be NO SMOKING in the cabanas, lockers or at poolside. There will be no smoking on the decks at the Beach Club. Members and guests are allowed to smoke on the beach or on the boardwalk and must be at least 100 feet from any public building or facility. If a member or guest does not comply, it will result in a \$100.00 fine or possible revocation of membership.
17. WADING POOLS – Children’s wading pools on the beach are not to exceed 52” in diameter and 11” in depth. THIS RULE WILL BE STRICTLY ENFORCED.
18. NORTH DECK RULES – Chairs and lounges only. No savings of lounges. No playpens or cribs allowed. No moving of furniture. No food of any kind.
19. SOUTH DECK RULES – Chairs and lounges only. No savings of lounges. No playpens or cribs allowed. No moving of furniture.
20. FOOD DECK – All members are allowed to eat on the restaurant food deck.
21. BEACH DECK AREA – No toys stored of any kind. All toys shall be stored overnight in the owner’s locker.
22. MEMBERSHIP CAP – Beach Club Membership is closed for 2015. Allenhurst residents and those persons who were Beach Club members during the prior Beach Club season will be approved for Club membership.
23. ADDITIONAL RULES – The management may put into effect, at any time, rules that are considered of benefit to the Beach Club or its patrons.
24. GENERAL CODE OF CONDUCT – In addition to the foregoing rules, each member and their guests are expected to be respectful to all staff and fellow members at all times. The goal of all ABC staff is to provide a peaceful family friendly environment and appropriate behavior from members and guests is the only way to achieve that goal. Therefore, loud and/or offensive language and obscene or otherwise inappropriate behavior is forbidden. Moreover, only the Club management is responsible for instructing and disciplining staff. Members and guests shall not criticize or denigrate ABC staff in any way. Although members are encouraged to report immediately to any Club employee any conditions or actions deemed hazardous to health and safety, complaints by members about staff behavior and job performance shall be made only to management. To ensure that such complaints are received and addressed appropriately, all complaints should be reduced to writing, signed by a member and left with management or e-mailed by a member to the Board of Commissioners.
25. CANCELATION OF MEMBERSHIP – The management reserves the right without refund of any payment to suspend or revoke membership privileges of anyone violating these rules. This includes resident and non-resident members and guests. Revocation of membership may be for one day, one week or entire year or for life. Decisions may be appealed at a regular meeting of the Board of Commissioners.

## **RULES FOR COMPLETING APPLICATION**

1. **SEASON:** The Beach Club will open on May 22<sup>nd</sup> for weekends only. The Club will open daily beginning on June 18<sup>th</sup>. The Club will close Sunday, September 13<sup>th</sup>, which will also be the last day for cleaning out lockers and cabanas. Please remember, all cabanas must be cleaned out completely as they will be moved at the end of the season. The hours of pool and ocean bathing are from 10 AM to 6 PM, with the exception of the period from July 1<sup>st</sup> to September 7<sup>th</sup>, when they shall be 10 AM to 7 PM. The Beach Club will be closed during inclement weather at the discretion of management.
2. **GUEST PACKAGES:** Each bathhouse or cabana is extended the privilege of buying unlimited guest packages for \$150.00 per package. There are ten passes per package. Single guest passes may be purchased for \$20.00 per pass. One guest pass is required per person during weekdays and two passes are required on weekends and holidays for adults 12 years and older. Only one pass will be required for children under age 12. Children under age 3 are free. **GUESTS WILL BE ADMITTED ONLY WHEN ACCOMPANIED BY A CLUB MEMBER. THIS RULE WILL BE STRICTLY ENFORCED,**
3. **MEMBERSHIP:** Each bathhouse shall not exceed 8 persons and each cabana shall not exceed 10 persons.
4. **RESIDENCY:** When filling out a resident application, please include as residents only those people who reside in Allenhurst during the summer months. Applications will be checked for accuracy.
5. **APPLICATION AND PAYMENT DEADLINE:** Your application is due on or before April 15, 2015. If your application is not received by this date, you will forfeit your facility. **THERE WILL BE NO EXCEPTIONS.** If you will not reserve your facility in 2015, please notify Allenhurst Borough Hall by phone or e-mail. Payment in full is due on or before May 15, 2015. After May 15, a late fee of \$250.00 will be assessed.
6. **PAYMENT:** Payment in full will be accepted **ONLY** from the principal applicant named on the application. There will be a \$20.00 returned check charge. All requests for membership refunds must be filed by July 1, 2015.
7. **SHARING A FACILITY:** When a resident and non-resident are co-principals and share a facility, the charges shall be half the fee for a AResident@, to be paid by the resident, and half the fee for a ANon-Resident@, to be paid by the non-resident.
8. **RENTALS:** If an applicant plans to rent in Allenhurst during the summer months, a Certificate of Occupancy must be presented in order to obtain resident rates. Summer renters are considered members for the current season only. Membership will not automatically be renewed. Allenhurst homeowners who are renting their homes for the summer will be subject to non-resident rates.
