

ALLENHURST BEACH CLUB RULES 2025

1. **Identification** – Entry to the Beach Club requires valid identification as a member or a guest of a member. All members must have a current photo on file. Failure to comply will result in membership suspension or revocation.
2. **Guests** – Guests must be accompanied by a Club member. Members who bring guests without payment may face suspension or revocation of their membership.
3. **Guest Passes** – Guest passes can be purchased online at www.abc1897.com or at the main gate. A package of 10 passes is available for \$250. Any Guest tickets purchased on or before June 30, 2025, will be sold at the discounted price of \$200. Guest Tickets purchased during the 2025 season will be good through the 2026 Season. There will be no refunds given for any Guest Tickets purchased. Additionally, Guest Tickets that were purchased during the 2024 season will be honored during the entire 2025 season. Guest Tickets purchased prior to 2024 are no longer valid.
4. **Resident Rates on Facilities** – Only one facility (locker or seasonal storage unit) is allowed per Allenhurst residential address. Only residential property owners and renters/tenants with current leases who reside in Allenhurst during the summer season are eligible for resident rates on facilities. Owners of commercially zoned properties are not eligible for resident rates. Anyone who falsely claims residency to obtain membership at the resident rate and does not reside in Allenhurst during the applicable summer season will have their membership and facility privileges revoked.
5. **Facility Capacity** – Locker areas have a maximum capacity of 10 members, while seasonal storage facilities are limited to 12 members. There will be no exceptions and no grandfathering.
6. **Licensing & Membership Transfers** – Sublicensing of your facility is prohibited. Anyone found to be soliciting for memberships, on social media or otherwise, risks losing their facility and Beach Club membership.
7. **Membership** – Membership for 2025 is currently closed. Allenhurst residents and 2024 members will receive priority when approval resumes.
8. **Late Payment Fee** – The deadline for the 2025 season payment is May 14. Payments made after this date will incur a \$250 late fee. There will be no exceptions.
9. **Storage for Kayaks, Canoes, and Paddleboards** – A storage rack is available for \$100 per season. Space is limited and offered on a first-come, first-served basis. Kayaks without a 2025 sticker will be removed. Stickers are available for purchase at the front office.
10. **Tents and Canopies** – As outlined in Ordinance 2025-05, only umbrellas with a central support structure are permitted, with a maximum size of 7 feet in diameter and 6 feet in height. "Baby tents" under 40 inches in height are allowed.
11. **Damage or Loss of Articles** – The Borough of Allenhurst is not responsible for any loss or damage to personal items left at the Club.
12. **Glassware** – Glass bottles are strictly prohibited around the pool and pool deck area or in the pool itself.
13. **Lounges** – Lounges are available on a first-come, first-served basis. They cannot be reserved or rearranged, and each member or guest is allowed only one lounge.
14. **Playpens and Strollers** – Playpens and strollers are not permitted in the main gate or

deck pavilion areas. Strollers should not be walked around the pool area.

15. **Chair Tags** – Chair tags will be available at the beginning of the season – one per member. Any chairs not tagged must be stored in the members' facility. All non-tagged chairs will be removed from the ABC.
16. **Children** – Children under 12 must be supervised by an adult at all times. Parents or guardians are responsible for their behavior, and disruptive children may be asked to leave.
17. **Trespassing** – Anyone entering the Beach Club unlawfully will be subject to fines.
18. **Pets** – Pets and other animals are not allowed on Beach Club property, including the boardwalk.
19. **Bathing** – Swimming is allowed in designated areas, and lifeguards will determine safe conditions. Surfing is prohibited where swimmers are present. There will be no lifeguards or beach set ups by staff south of the restaurant.
20. **Grounds** – Members and guests must keep the facilities clean. Decks, stairs, and passageways must remain clear. Any property damage may result in expulsion and prosecution. Smoking is not permitted within the facility or near seasonal storage units.
21. **Wading Pools** – Children's wading pools must not exceed 52 inches in diameter and 11 inches in depth.
22. **Diaper Changing** – Diapers may only be changed in designated areas, such as lockers, seasonal storage units, or restrooms. Diaper changing is not permitted on lounges or in any public area.
23. **Deck Rules** – Only chairs and lounges are permitted on the North and South Decks. Saving lounge chairs, playpens, or cribs is prohibited. Furniture must not be moved, and food is not permitted on the decks.
24. **General Code of Conduct** – All members and guests must treat staff and fellow members with respect. Complaints must be submitted in writing to the Beach Club Office.
25. **Violations of Rules** – Members are responsible for ensuring compliance with all Beach Club rules and must show respect for all members, guests, and employees. Principals on facilities are responsible for the behavior of all members in their facility. Violations of the rules will result in a week's suspension from the club. Second offenses will result in expulsion without refund.
26. **Rule Modifications** – The Allenhurst Commissioners reserve the right to amend these rules at any time as deemed necessary for the benefit of the Beach Club and its members.
